During this action the HMCS ANNAN sinks the U-Boat U-1006 with assistance from HMCS Cape Breton and the HMCS GROU. The HMCS Cape Breton engages a second submarine, probably the U-978 which escapes in the ice pack. All three of these ships were River Class frigates.
