(5) On being enrolled as a member of the OTTAWA Division Royal Canadian Naval Volunteer Reserve, I undertake and bind myself:-(a) To serve from the date thereof for three consecutive years, being subject to the provisions of the Naval Service Act, and of the Regulations made in pursuance thereof for the government of the Royal Canadian Naval Volunteer Reserve, and to the customs and usages of His Majesty's Canadian Naval Service. (b) To report for active service if called upon in time of war or emergency, and, if called into active service, to serve ashore or afloat as may be directed, according to where my services are required. , for (c) To keep in good repair and condition the articles of uniform and any articles of outfit which may be issued to me and to return them to the nearest Divisional Commanding Officer or to Training Headquarters prior to my discharge or when required so to do by any authorized person, or to pay compensation for any loss or damage thereto other than fair wear and tear; and also not to wear such uniform or outfit (which is and remains the property of the Crown) except when on naval duty. Dear Mrs. McConnell:

It is with deepest regret that I must confirm the telegram of the 17th of April. 1945, from the Minister of National Defence for Naval Services, informing you that your son, Lawrence Michael McConnell, Leading Seaman, Official Mumber V-6640, Royal Canadian Naval Volunteer Reserve, has been killed in action.

For security reasons, the only information which may be released at this time is that your son's death was due to enemy action.

As you are aware, his body was recovered and, in accordance with your wishes, is being sent, at public expense, to Ottawa. You will be informed of the date and time of arrival by the Commanding Officer, H.M.C.S. BITOWN. Ottawa, Ont., who will be pleased to assist you in making any necessary arrangements for the funeral. The Protestant Naval Chaplain, the Rev. G. L. Douglas, who has already contacted you, is also available should you require any further assistance.

It is requested that you will regard the name of the ship in which he was serving, together with the fact that she has been in contact with the enemy, as secret until an official announcement is made.

Please allow me to express sincere sympathy with you in your bereavement on behalf of the Minister of National Defence for Naval Services, the Chief of the Maval Staff, and the Officers and men of the Royal Canadian Navy, the high traditions of which your son has helped to maintain.
