Your son was serving in H.M.C.S. "SPIKENARD" which was torpedoed and sunk by enemy action on the 10th February 1942. Details of the action are not, however, available at this time.

must be presumed lost on Active Service.

The possibility of your son having been rescued by other ships cannot be estimated but it has been established that he was not among the survivors landed at a United Kingdom port and very little is held out for the survival of the remainder. You will be informed immediately should any further information be received.

I wish to express the sincere sympathy of the Chief of the Naval Staff, Officers and men of the Royal Canadian Navy, the high traditions of which your son has helped to maintain.
